PROVIDES DIRECT FEEDBACK ON MENTAL HEALTH ISSUES TO INSTITUTIONAL STAFF. ASSISTS IN DISCHARGE PLANNING. PROVIDES ADVISORY AND CONSULTATIVE SERVICE AS RELATED TO MENTAL HEALTH SERVICES, ASSIST SUPERVISOR IN THE DEVELOPMENT/ADMINISTRATION OF SPECIAL PROJECTS; ASSISTS OTHER INSTITUTIONS AS NEEDED; PARTICIPATES IN ON-CALL POOL TO PROVIDE AFTER HOUR AND ON-SITE WEEKEND/HOLIDAY COVERAGE TO THE INSTITUTIONS AS ASSIGNED.
