**COLUMBIA, S.C.** – The SCDC Office of Investigations and Intelligence released the arrest warrants today for unrelated incidents involving two correctional officers at Broad River Correctional Institution.

Martyna Tanaisha Green, 26, of Columbia is charged with possession of marijuana with intent to distribute, providing contraband to a prisoner and misconduct in office. Her charges involve 143 grams of a green, leafy substance believed to be marijuana concealed in two vacuum-sealed packages hidden inside her SCDC vest. She was fired after her arrest.

Shanekia Dickerson, 29, of Columbia is charged with providing contraband to a prisoner and misconduct in office. Her charges involve bringing 20 Newport cigarettes into the institution concealed in a pink wallet.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
