**COLUMBIA, S.C.** – The S.C. Department of Corrections Police Services released the arrest warrant today for former Correctional Officer Tyshiana Brown, 24, of Iva.

Brown, a former officer at McCormick Correctional Institution, is charged with providing contraband to an inmate, misconduct in office and threatening the life of a public official (two correctional officers.)

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.

On April 1, 2019, Tyshiana Brown, a public official working for the South Carolina Department of Corrections, did commit the crime of misconduct in office by conspiring to conceal contraband (tobacco) on her person and introducing said contraband into McCormick Correctional Institution. Brown communicated with inmates currently incarcerated at McCormick Correctional Institution via telephone including text messages and nude photographs exchanged with inmates. This information was provided by written officer and inmate testimonies and corroborated with documented text messages from Tyshiana Brown's cellular phone.
