

South Carolina Department of Corrections Announce Arrest

COLUMBIA, S.C. – The S.C. Department of Corrections Police Services released the arrest warrants today for Jahbrisha Marie Ebony Pennick, 31, of Ladson.

Pennick is charged with distribution of marijuana, criminal conspiracy and two counts of introducing contraband into MacDougall Correctional Institution.

Pennick is charged with leaving marijuana and tobacco at a rest area off Interstate 26 with the intention of the drugs being picked up by an inmate on a MacDougall litter crew and delivered to another inmate at the institution.

The case remains under investigation, and further charges could be filed.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
