COLUMBIA, S.C. – The S.C. Department of Corrections Police Services released the arrest warrant today for former Correctional Officer Reginald Keith Gadson.

Gadson, a former officer at Lieber Correctional Institution, is charged with assault & battery 3rd degree and misconduct in office.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
