**COLUMBIA, S.C.** – The S.C. Department of Corrections Police Services released the arrest warrants today for Calandra Shantelle Holden, 36, of Toccoa, Ga.

Holden was visiting an inmate recently when she was charged with criminal conspiracy to introduce contraband into Tyger River Correctional Institution.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
