COLUMBIA, S.C. – The S.C. Department of Corrections Police Services released an arrest warrant today charging an inmate with conspiring to introduce contraband into MacDougall Correctional Institution.

Inmate Antawan Lloyd, SCDC No. 322897, is charged with criminal conspiracy.

Jahbrisha Marie Ebony Pennick, 31, of Ladson, was charged in this case last month with distribution of marijuana, criminal conspiracy and two counts of furnishing contraband to a prisoner.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
