**COLUMBIA, S.C.** – The S.C. Department of Corrections Police Services released the arrest warrants today for two people accused of working together to bring contraband into SCDC prisons through the department's Walden Prison Farm.

Jasmine Odessa Isom, 32, of Greenwood, is charged with attempting to introduce contraband into a prison and criminal conspiracy. Tremayne Daryl Isom, 37, also of Greenwood, is charged with criminal conspiracy.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
