COLUMBIA, S.C. – The S.C. Department of Corrections Police Services released the arrest warrant today for Cedric Major, 28, of St. Helena Island.

Major, who was working as a correctional officer at Ridgeland Correctional Institution, was charged with misconduct in office. He was fired today after his arrest. The incident was reported as an inmate-on-inmate assault, and during the course of the investigation, charges were brought against Major.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
