COLUMBIA, S.C. – The S.C. Department of Corrections Police Services released the arrest warrants today for two correctional officers charged with bringing contraband into Broad River Correctional Institution.

Correctional Officers Kenneth Terrell Lewis, 40, of Columbia, and Rashawndra L. Shanks, 27, of Greensboro, N.C., were both charged with introducing contraband into the prison and misconduct in office. Both are no longer with the agency.

Civilian Jennifer Marie Johnson, 37, of Columbia, also is charged in the case with harboring or concealing Lewis' whereabouts.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
