COLUMBIA, S.C. – The S.C. Department of Corrections Police Services released the arrest warrant today for Lloyd Franklin, 76, of Spartanburg, on a charge of providing contraband to inmates.

Franklin, a transportation driver assigned to the litter crew at Livesay Correctional Institution, is accused of taking inmates to spots along Interstate 85 to retrieve contraband left for them. He was fired after his arrest.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
