**COLUMBIA, S.C.** – The S.C. Department of Corrections Police Services released the arrest warrant today for Correctional Officer Bianca Davis, 28, of Lincolnton, Ga., for misconduct in office.

Davis, who was working at McCormick Correctional Institution, is charged with having a personal relationship with an inmate. She was fired after her arrest.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.

**Affidavit:**

Agent Christopher Long, states that the defendant, did in the County of McCormick, South Carolina between the dates of May 1, 2019 and June 2, 2019 commit the offense of (Misconduct in Office) to wit: that Bianca Davis, a Sworn Officer with the Department of Corrections, did willfully, dishonestly, and with corrupt intent, engage in misconduct by having a personal relationship with [REDACTED] a lawfully incarcerated inmate within the SC Department of Corrections. The defendant sent nude pictures to [REDACTED] via a contraband cell phone. Pictures and messages were also recovered from a search warrant of Davis' Face Book account. There were messages about how she could get contraband through the machine at the front gate. Numerous messages were sent between Davis and [REDACTED] expressing how much they loved each other. The offense occurred at the McCormick Correctional Institution, 386 Redemption Way, McCormick 29899, SC. Probable cause is based upon Police investigation and recovery of electronic evidence.
