**COLUMBIA, S.C.** – The S.C. Department of Corrections Police Services released the arrest warrant today for former inmate Marcus Antonio Wright, charging him with murder in the death of Matthew Williams.

Williams, 31, was found dead in his cell at Lieber Correctional Institution Sept. 13. Wright and Williams were cellmates.

Wright, 23, has twice served time in SCDC for burglary. He finished serving his latest sentence for burglary and smuggling on Oct. 1, 2019. He was released to the Dorchester County Sheriff's Department, where he remains in custody at the Dorchester County Detention Center as he faces the murder charge.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
