**COLUMBIA, S.C.** – The S.C. Department of Corrections Police Services released the arrest warrant today for U’Nece Briscoe, a visitor to Evans Correctional Institution on Sunday.

Briscoe, 34, of Inman, was charged with attempting to furnish contraband to a prisoner. Her charges involve the discovery of packages of marijuana wrapped in electrical tape in her shoes as she attempted to enter the institution’s front gate.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.

The packages contained a quantity of a green leafy substance that field tested positive for marijuana.
