COLUMBIA, S.C. – The S.C. Department of Corrections Police Services released the arrest warrant today for Rachel Denee Alston, a correctional officer at Broad River Correctional Institution.

Alston, 43, of Elgin, is charged with misconduct in office. Her charges involve accepting money from an inmate in 2018 and communicating with him by telephone. She was fired after her arrest.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
