COLUMBIA, S.C. – The S.C. Department of Corrections Police Services released the arrest warrant today for a North Carolina man in connection with a contraband incident at Lee Correctional Institution Monday.

Terrell Laqua Smith, 20, of Winston-Salem, is charged with introducing contraband into a state prison. The charges involve attempting to throw two packages over the prison's barrier fence. The packages contained a cell phone, wrapping paper, loose tobacco and lighters.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
