**COLUMBIA, S.C.** – The S.C. Department of Corrections Police Services released the arrest warrants today for Loren Russell Smith, a correctional officer at Lee Correctional Institution.

Smith, 38, of Florence, is charged with possession with intent to distribute marijuana, introducing contraband into a prison, criminal conspiracy and misconduct in office. His charges involve attempting to bring 256 grams of marijuana and rolling papers into the prison hidden inside a Taco Bell food container. He was fired after his arrest.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
