**COLUMBIA, S.C.** – The S.C. Department of Corrections Police Services released the arrest warrant today for Karen H. Tuttle, a former correctional officer at Goodman Correctional Institution.

Tuttle, 55, of Columbia, is charged with misconduct in office. The charges against her involve using various cash applications to exchange money with an inmate at Turbeville Correctional Institution and communicating with him by telephone. She is no longer employed by the department.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
