COLUMBIA, S.C. – The S.C. Department of Corrections Police Services released the arrest warrants today for two correctional officers in unrelated cases.

Tomika Garvin, 31, of Estill, is charged with possession with intent to distribute marijuana and LSD and providing contraband to a prisoner. Her charges involve 251.4 grams of a substance believed to be marijuana and LSD hidden on her person as she entered Allendale Correctional Institution, where she worked.

Albany Carisma Dupont, 22, of Bluffton, was charged with misconduct in office and criminal conspiracy. Her charges involve bringing water bottles filled with alcohol into Ridgeland Correctional Institution, where she worked.

Both were fired after their arrests.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
