COLUMBIA, S.C. – The S.C. Department of Corrections Police Services released the arrest warrants today for Jhane Schenora King, 27, a mental health officer at Gilliam Psychiatric Hospital.

King, 27, of Columbia, is charged with furnishing a prisoner with contraband and misconduct in office. The charges against her involve bringing a gold necklace, photographs of herself and food into Kirkland Correctional Institution, where the hospital is located, and delivering them to an inmate. Charges also allege she engaged in a personal relationship with the inmate and shared several letters of a sexual nature with him. She has been fired.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
