**COLUMBIA, S.C.** – The S.C. Department of Corrections Police Services released the arrest warrants today for Jhane Schenora King, 27, a mental health officer at Gilliam Psychiatric Hospital.

King, 27, of Columbia, is charged with furnishing a prisoner with contraband and misconduct in office. The charges against her involve bringing a gold necklace, photographs of herself and food into Kirkland Correctional Institution, where the hospital is located, and delivering them to an inmate. Charges also allege she engaged in a personal relationship with the inmate and shared several letters of a sexual nature with him. She has been fired.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.

I further state that there is probable cause to believe that the defendant named above did commit  
the crime set forth and that probable cause is based on the following facts:

Between the times of April 2020 to September 8, 2020, the defendant Jhane' S. R. King, a sworn officer with the South Carolina Department of Corrections, did willfully, dishonestly and with corrupt intent, engage in corruption, in the form of malfeasance, misfeasance, or nonfeasance, by committing acts in violation of her duty of good faith, honesty and accountability of public trust as a State Correctional Officer. These acts include bringing food, a gold in color necklace with a "J" charm, and photographs of herself to inmate who is a lawfully incarcerated inmate. King also kissed inmate on two separate occasions and wrote several letters back and fourth of a sexual nature. King admitted that she started a relationship with around April of 2020. This incident occurred at Kirkland Correctional Institution, 4344 Broad River Road, Richland County, Columbia, SC 29210. Evidence is provided in a written confession, statements, and other supportive evidence.
