COLUMBIA, S.C. – The S.C. Department of Corrections Police Services released the arrest warrant today for Micaela Addison, a lieutenant at Lee Correctional Institution.

Addison, 35, of Lumberton, N.C., is charged with misconduct in office. The charges against her involve having an inappropriate relationship with an inmate. She is no longer employed by the department.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
