COLUMBIA, S.C. – The S.C. Department of Corrections Police Services released the arrest warrant today for Angela Lynn Kirk, a correctional officer at Kershaw Correctional Institution.

Kirk, 26, of Kershaw, is charged with misconduct in office. Her charges involve having an inappropriate relationship with an inmate through text messages, photographs and multiple video communications. She is no longer employed with SCDC.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.

offense of; Misconduct in Office, by engaging in an inappropriate relationship with an inmate ([REDACTED] at Kershaw Correctional
Institution, and abusing her position as a Correctional Officer by having outside contact with an inmate violating SC Department of
Corrections policy and state policy as well. Throughout this time period Officer Kirk sent text messages, pictures, and had multiple
video communications with the inmate. Probable cause is based on picture/video evidence, and officer statement to Police Services
