**COLUMBIA, S.C.** – The S.C. Department of Corrections Police Services released the arrest warrants today for Brittany Willoughby, a correctional officer at Evans Correctional Institution.

Willoughby, 23, of Morven, N.C., is charged with introducing contraband into a prison, criminal conspiracy and misconduct in office. Her charges involve bringing in two water bottles filled with vodka with the intention of delivering them to an inmate for \$500. She was fired after her arrest.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
