**COLUMBIA, S.C.** – The S.C. Department of Corrections Police Services released the arrest warrant today for Aaron Coleman Jones, a contract licensed practical nurse at Camille Graham Correctional Institution.

Jones, 40, of Irmo, is charged with second degree criminal sexual conduct with an inmate patient. He no longer works within SCDC.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
