COLUMBIA, S.C. – The S.C. Department of Corrections Police Services released the arrest warrants today for Yvette Phillips, a nurse contracted to work at Kirkland Correctional Institution.

Phillips, 53, of Columbia, is charged with possession of oxycodone, possession of Diazepam and providing contraband to a prisoner. Her charges involve bringing contraband pills into the institution and concealing them in a black rubber glove. She will not be allowed to work at SCDC again.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
