COLUMBIA, S.C. – The S.C. Department of Corrections Police Services released the arrest warrants today for Quincena Murray, a lieutenant at Turbeville Correctional Institution.

Murray, 48, of Greeleyville, is charged with possession of marijuana with intent to distribute, furnishing or attempting to furnish a prisoner with contraband and misconduct in office. Her charges involve 798 grams of marijuana, 816 grams of tobacco, loose cigarettes and various types of cigar wraps and alcohol wrapped in duct tape hidden in the back seat floorboard of her car. She was fired after arrest.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
