COLUMBIA, S.C. – The SCDC Office of Investigations and Intelligence released the arrest warrants today for three civilians on contraband charges stemming from incident overnight at Livesay Correctional Institution.

Lindbergh Hamilton Jr., 48, Joshual Rashaan Morris I, 32, and Anthony King, 45, all of Gaffney, are each charged with:

- Attempting to furnish contraband to a prisoner.
- Possession of 15 units of ecstasy.
- Possession with intent to distribute synthetic marijuana, commonly known as K2.
- Attempt and conspiracy to introduce drugs and contraband into a prison.

The three men were arrested outside the perimeter of Livesay CI last night. The charges involve a package of contraband that included ecstasy, K2, cigarettes, telephone cards and other contraband.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
