**COLUMBIA, S.C.** – The SCDC Office of Investigations and Intelligence released the arrest warrants today for a food service worker at Tyger River Correctional Institution.

Maranda Jean Sain, 39, of Clinton, is charged with first-degree sexual misconduct with an inmate and providing contraband to inmates. Her charges involve engaging in an ongoing inappropriate sexual relationship and providing cigarettes to inmates. She was fired after her arrest.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
