COLUMBIA, S.C. – The SCDC Office of Investigations and Intelligence released the arrest warrant today for Christopher Thompson, a supervisor in the fabric shop at Camille Graham Correctional Institution.

Thompson, 55, of Columbia, is charged with first degree sexual misconduct with an inmate. His charge involves sexual activity with an inmate in a back area of the fabric industries building at Camille Graham CI. He was fired after his arrest.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
