**COLUMBIA, S.C.** – The SCDC Office of Investigations and Intelligence released the arrest warrant today for Christopher Thompson, a supervisor in the fabric shop at Camille Graham Correctional Institution.

Thompson, 55, of Columbia, is charged with first degree sexual misconduct with an inmate. His charge involves sexual activity with an inmate in a back area of the fabric industries building at Camille Graham CI. He was fired after his arrest.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

During the month of either June or July 2020, the defendant, Christopher Thompson, did commit the crime of sexual misconduct with an inmate by receiving oral sexual intercourse from the victim, inmate [REDACTED] who is lawfully incarcerated inmate with the South Carolina Department of Corrections. The defendant admitted that he received oral sex from the victim one time while he was a supervisor of the victim working at the fabric industry building located inside of Camille Griffin Graham Correctional Institution at 4500 Broad River Road, Richland County, Columbia, SC 29210. The defendant went to the back area of the building inside of a caged room where the victim preformed oral sex on him. Evidence is provided with the victim's statement and the defendant's written confession.
