**COLUMBIA, S.C.** – The SCDC Office of Investigations and Intelligence released the arrest warrants today for Reginald Jamar Sims, who was arrested outside of McCormick Correctional Institution on Monday.

Sims, 24, of Clinton, is charged with possession with intent to distribute marijuana, providing contraband to a prisoner and trespassing. His charges involve attempting to throw eight packages of contraband over the fence at McCormick. The packages contained 241 grams of marijuana, three pounds of tobacco, six cellphones and other items that are not allowed inside the prison.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.

SCDC thanks the McCormick County Sheriff's Department for their assistance in this case.
