**COLUMBIA, S.C.** – The SCDC Office of Investigations and Intelligence released the arrest warrant today for additional charges against a former officer at Allendale Correctional Institution.

Tomika Garvin, 32, of Estill, is charged with first-degree sexual misconduct with an inmate. The charges against her involve having a sexual relationship with an inmate, who by law cannot consent.

In August, Garvin was charged with possession with intent to distribute marijuana and LSD and providing contraband to a prisoner. Those charges involve 251.4 grams of a substance believed to be marijuana and LSD hidden on her person as she entered Allendale CI, where she worked.

She was fired after her August arrest.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
