COLUMBIA, S.C. – The SCDC Office of Investigations and Intelligence released the arrest warrants today for a licensed practical nurse at Broad River Correctional Institution.

Kristen Hair Hildebrand, 35, of St Matthews, is charged with possession of marijuana with intent to distribute and furnishing contraband to a prisoner. Her charges involve entering the institution with 195 grams of a substance that field tested positive for marijuana stuffed into highlighter pens, along with rolling papers. She was fired after her arrest.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
