COLUMBIA, S.C. – The SCDC Office of Investigations and Intelligence released the arrest warrants today for a Columbia man who was arrested near the Columbia prison complex on drug charges.

Damien Belafonte Jones Counts, 43, was arrested in the 1100 block of Piney Grove Road. He is charged with possession of drugs with intent to distribute, pointing a firearm and unlawfully carrying a pistol. The incident occurred when SCDC police agents were returning to the Broad River Road complex. A man with a gun was chasing someone and ran in front of the agents' car.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
