COLUMBIA, S.C. – The SCDC Office of Investigations and Intelligence released the arrest warrants today in a mail drug operation at Lieber Correctional Institution.

Lisa D. Avins, 62, of Sumter, was arrested and is charged with:

- 10 counts of distribution of methamphetamines.
- Two counts of possession of suboxone with intent to distribute.
- Five counts of providing contraband to a prisoner.
- One count of criminal conspiracy.
- One count of possession of meth.

The charges involve sending meth, suboxone and tobacco through the mail to various inmates at Lieber, with instructions to give the drugs to an inmate who is connected to Avins.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
