COLUMBIA, S.C. – The SCDC Office of Investigations and Intelligence released the arrest warrants today for a Williston woman accused of sending drugs through the mail to an inmate.

Courtney Ann Barwick, 29, is charged with possession of drugs with intent to distribute, providing contraband to a prisoner and criminal conspiracy. Her charges involve mailing letters that contained suboxone strips to an inmate at Leath Correctional Institution.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.

In furtherance of this conspiracy, Defendant did send letters through the U. S. Mail with Suboxone strips concealed underneath stamps to an inmate at LCIW with the intent that the Suboxone be distributed to SCDC inmates for profit. These items are considered contraband by the Director of SCDC and inmates are not allowed to possess them.
