COLUMBIA, S.C. – The SCDC Office of Investigations and Intelligence released the arrest warrants today for two people attempting to smuggle contraband into Livesay Correctional Institution.

David Mark Horne Sr., 52, and Carmen Linda Irvin, 43, both of Greenwood, are each charged with providing contraband to prisoners and criminal conspiracy. The charges involve a package being delivered to the prison containing about 10 pounds of loose tobacco, cell phones, chargers, earbuds, smokeless tobacco and other banned items.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
