COLUMBIA, S.C. – The SCDC Office of Investigations and Intelligence released the arrest warrants today for the commissary manager at Livesay Correctional Institution.

Vickie Renee White, 49, of Chester, is charged with first degree criminal sexual conduct with an inmate and misconduct in office. The charges against her involve an ongoing sexual relationship with an inmate beginning in January 2022. She was fired.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
