COLUMBIA, S.C. – The SCDC Office of Investigations and Intelligence released the arrest warrant today for a Licensed Practical Nurse at Livesay Correctional Institution.

Shimano Cheek-Mcfadden, 32, of Spartanburg, is charged with providing contraband to an inmate. The charge includes providing an illegal cellphone to an inmate. She was fired.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
