**COLUMBIA, S.C.** – The SCDC Inspector General released arrest warrants today for a food warehouse worker on drug and contraband charges.

Javaris Marquies Da'Sant, 20, of Columbia, is charged with trafficking in methamphetamines, possession with intent to distribute synthetic marijuana and providing contraband to prisoners. He was fired.

The charges involve a large amount of contraband found inside the food warehouse and in Da'Sant's car, including:

- 109 grams of a substance that field tested positive for meth.
- 23,107 grams of tobacco.
- 1,647 grams of a substance that field tested positive for synthetic marijuana.
- Cellphones, chargers, charging blocks, earbuds and SIM cards.
- Rolling papers, glass pipes and cigarettes.
- Tattoo ink and hair clippers.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.

This baggy was recovered during a lawful search of his vehicle a white, 2014 Kia Optima (SC temp tag:  The white, crystal like substance field tested positive for Methamphetamine with a field weight of 109 grams. The items were recovered from a black rolling suitcase which the defendant admitted to being in the backseat of his vehicle. Probable cause is based on the investigation, recovery of evidence, and the defendant's own admission.
