COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrants today for a Spartanburg woman arrested on contraband charges at Tyger River Correctional Institution.

Jennifer Renee Williams, 41, is charged with providing contraband to a prisoner and criminal conspiracy. Her charges involve providing tobacco and cellphones to an inmate at Tyger River.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
