**COLUMBIA, S.C.** – The SCDC Inspector General released the arrest warrants today for a North Carolina man arrested on contraband charges involving inmates at Lieber Correctional Institution.

Travell Levone Hill, 37, of Dallas, N.C., is charged with:

- Trafficking in methamphetamines more than 28 grams.
- Possession of marijuana with intent to distribute.
- Possession of suboxone with intent to distribute
- Criminal conspiracy.
- Providing contraband to prisoners.

Hill was spotted on surveillance cameras walking onto the Lieber property from nearby railroad tracks. SCDC launched its drone team, which led officers to Hill's location using thermal imaging technology. When he was arrested, he was carrying a bag containing 175 grams of a substance that tested positive for marijuana, 88 grams of a substance that tested positive for meth, suboxone strips, tobacco and other contraband items.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
