COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrants today for a Bonneau woman arrested on contraband charges involving an inmate at MacDougall Correctional Institution.

Lisa Dermady Barrs, 44, is charged with:

- Possession of narcotics with intent to distribute.
- Criminal conspiracy.
- Providing contraband to a prisoner.

Barrs' charges involve conspiring with an inmate to throw packages of contraband containing Suboxone strips, tobacco and other contraband items over a fence at MacDougall.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.

29472. Contents of one of the packages yielded four hidden pink like stickers with A8 written on them glued to a yellow envelope
like paper which field tested presumptive for Suboxone. The defendant did have the intent to distribute the Suboxone to a South
Carolina Department of Corrections (SCDC) inmate. Probable cause is based on multiple recorded phone conversations through the
