COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrants today for a Lexington woman arrested on contraband charges involving an inmate at Camille Graham Correctional Institution.

Tammy Dianne Anslow, 64, is charged with providing contraband to a prisoner and criminal conspiracy.

The charges involve conspiring with an inmate to leave a package of methamphetamines near the prison for the inmate to retrieve.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.

via phone calls & verbal communication from Jan. 17, 2023 to Jan. 23, 2023, a plan for the Co-Defendant to smuggle in narcotics to
Camille Griffin Graham Correction Institution (CGGCI). On Jan. 19, 2023 the Co-Defendant communicated with the Defendant
step-by-step instructions as to where to retrieve & place the package containing 15 grams of methamphetamine. The package was
intended to be smuggled into CGGCI as contraband. Probable cause is based on the admission of guilt made from Defendant &
Co-Defendant post Miranda & recorded phone calls made by the Defendant to Co-Defendant. Affiant & others are witness to prove
