**COLUMBIA, S.C.** – The SCDC Inspector General released arrest warrants today for a correctional officer at Lee Correctional Institution.

Alkeena Eu-Neiger Hackett, 26, of Greenwood, is charged with trafficking fentanyl, providing prisoners with contraband and criminal conspiracy. Hackett was discovered attempting to bring a metal grill mouthpiece into Lee CI hidden in her hair. In a further search of her vehicle, officers found a rock-like substance weighing 129 grams that field tested positive for fentanyl. She was fired after her arrest.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
