**COLUMBIA, S.C.** – The SCDC Inspector General released arrest warrants today for a correctional officer at Lee Correctional Institution.

Alkeena Eu-Neiger Hackett, 26, of Greenwood, is charged with trafficking fentanyl, providing prisoners with contraband and criminal conspiracy. Hackett was discovered attempting to bring a metal grill mouthpiece into Lee CI hidden in her hair. In a further search of her vehicle, officers found a rock-like substance weighing 129 grams that field tested positive for fentanyl. She was fired after her arrest.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

On May 3, 2023, while being scanned in for her shift at Lee Correctional Institution (LeeCI) located at 990 Wisacky Highway Bishopville, SC 29010, in the County of Lee the defendant Alkeena Hackett did violate section 44-53-0370(e)(3)(C) of the South Carolina code of laws. Drugs/ Trafficking in Heroin, morphine, etc 28 g or more, to wit: the defendant was caught attempting to smuggle a metal mouthpiece (grill), into LeeCI by concealing it inside of her hair. Officers conducted a search of the defendant's vehicle and located a package wrapped in black electrical tape in her purse along with the defendant's SCDL. The package is consistent with other packages that have been introduced into correctional institutions. The package contained approximately 129 grams of a rock-like substance which tested presumptive for fentanyl utilizing the MobileDetect Field Test Kit.
