COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrants today for a Bethune man on drug and contraband charges involving inmates at McCormick Correctional Institution.

Quinton Alexander Douglas, 27, is charged with providing contraband to prisoners, possession of marijuana with intent to distribute and criminal conspiracy. The charges involve flying a drone containing tobacco, marijuana, cellphones and other contraband items onto the prison yard.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.

Copies of the arrest warrants are attached.
