**COLUMBIA, S.C.** – The SCDC Inspector General released arrest warrants today for a nursing assistant at Leath Correctional Institution.

Lativa Nakash Hill, 38, of Greenwood, is charged with providing prisoners with contraband and drug possession. Her charges involve bringing suboxone and buprenorphine strips into the institution inside her work bag. She was fired.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
