COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrants today for a former inmate on contraband charges involving a drone at Ridgeland Correctional Institution.

Alex Wartara Nash, 43, of Spartanburg, is charged with possession of marijuana with intent to distribute, providing contraband to prisoners and criminal conspiracy. His charges involve attempting to fly a drone carrying marijuana onto the Ridgeland prison yard.

At the time of his arrest, Nash was out on bond from [charges involving flying a drone](#) carrying contraband on the Lieber prison yard in August.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.

with intent to Distribute Marijuana (PWID) in that: Defendant was located in the solar panel field within the Town of Ridgeland
South Carolina 29936 and in the immediate proximity to Ridgeland Correctional Institution (RCI). This area is an established
known flight location for introducing contraband into RCI using (AI) or drone air flight apparatuses. Special Agents were in the
area when the defendant was dropped off in the solar panel field. Special Agents conducted a K9 track and located and detained the
defendant a short distance away. Special Agents conducted a search of the area in which an orange unmanned aerial AI drone
vehicle and a black duffel bag containing wrapped contraband packages. A clear plastic bag containing approximately 49 grams of
green leafy substance was located which did field test presumptive for Marijuana. Affiant, witnesses and others to prove same.
